



- 1. In 2022, the number of patent applications filed with the NOIP continued to increase compared to 2021, specifically the number of patent applications filed with the NOIP was 9,308 applications, an increase of 1.9% compared to 2021;
- 2. Regarding formal examination: The PEC has completed formal examination for 9620 applications, an increase of about 6.8% compared to 2021;
- 3. Regarding substantive examination: The PEC has finished substantive examination for 7698 applications (of which 4111 applications are granted, 1940 applications for refusals) an increase of about 4.3% compared to 2021.

#### **Number of Anual Applications and Patents**






#### 2. Overview of Patent Examination Process





# 2. General procedure of formality check






The centralized modality formalities checks for all patent applications, in which all patent examiners have taken part in formalities checks in rotating form, and after completing the formalities checks, all patent applications are stored and monitored by PEC's authorized officials. At the stage of Substantive examination, applications will be allocated to specific sections based on IPC of the applications.

# 2. General procedure of substantive examination






#### 2. Paper-based Examination



The examination system relies heavily on paper-based control (formality check, storing applications, substantive examination and approval)

#### 3. Challenges in 2023



- More than 20,000 pending applications in 2023 vs capacity of handling is about 8,000 patent applications per year; ☐ PEC is yet to be given autonomy to run its operation; ☐ Prior art searching tools mostly depend on free databases on the internet; ☐ New IP amended Law come to effect from 01 Jan 2023, while Legal instruments (Decree and Circular) for prescribing details on the Amended IP Law are yet to be approved; These instruments should have come to effect the same day as IP amended law; ☐ IT infrastructure at IP Viet Nam is yet to meet the demand for patent examination;
- Recruiting new patent examiners is not easy.

### 3. Main Strategies and Initiatives



- □ Setting up a plan for processing pending patent applications and the target of closing patent applications for each Department and each patent examiner right at the beginning of the year, taking into account the increase in new applications in 2022
- ☐ Studying and formulating software tools for managing and monitoring the implementation of the plan of each patent examiner in the PEC
- □ Promoting the modality of patent examination in groups of 3 people (1 patent examiner, 1 Head of Department, and 1 leader of the Center) for complete settlement of longer pendency patent applications, and complicated patent applications that relate to many technical fields

# 3. Main Strategies and Initiatives



☐ Enhancing the skill-sharing, and the professional competencies-sharing amongst experienced patent examiners and new patent examiners
□ PEC's leadership and Heads of Departments regularly urge and remind patent examiners to closely follow patent processing plans, and promptly encourage their efforts
$\square$ IP Viet Nam launches emulation movement among its units and reward in time individuals that record outstanding achievements in the patent examination for dealing with backlog
☐ Simplifying the process of patent examination, removing unnecessary steps
Unifying, systemizing, and standardizing some forms of notification
$f\square$ Stepping up the decentralization, the allocation of responsibilities in processing patent applications
