POSITIONS AND FUNCTIONS

Trademark Examination Center (TEC) is a public non-business unit under Intellectual Property Office of Vietnam (established on March 06, 2019 from reorganization of Trademark Division No. 1 and Trademark Division No. 2) with function of assisting the General Director in the examination of trademark registration applications (except for collective marks, certification marks and international marks) and implementing activities related to this object.

TEC has its headquarter in Hanoi.

TASKS AND ENTITLEMENTS

- Prepare and submit to the Director General of IP Vietnam the direction and operation plan of the Center and organize the implementation after it is approved.
- 2. Examine trademark registration applications.
- 3. Organize the compilation of professional documents regarding examination of trademark registration applications.
- 4. Participate in building database, search engine, management program, administration and automation of the trademark application examination process.
- 5. Provide professional opinions to serve the settlement of disputes and complaints related to the establishment of trademark rights.

TASKS AND ENTITLEMENTS (CONT)

- 6. Organize and implement programs, projects and scientific research topics related to trademarks.
- Participate in professional training and cultivation in the assigned field.
 Coordinate to carry out cooperation activities with domestic and foreign agencies and organizations regarding the contents within the scope of the assigned functions and tasks as prescribed by law.
- 9. Report and make periodical or irregular data statistics on the processing of trademark registration applications.
 - 10. Manage human resources, finance, assets and documents of the Center in accordance with law.
 - 11. Perform other tasks assigned by the Director General of IP Vietnam.

80 staff including 18 Formality Examiners, 40 Substantive Examiners and 19 Trademark Researchers divided into 5 Sections:


