### Big changes are taking place...



## Global IP Surge – Shifting Gravity

- Innovation and IP shifting towards Asia, Africa, and Latin America
- Emerging economies driving global IP growth
- 75% of IP filings now from Global South, up from 60% in 2012 and 50% in 2002
- India: IP filings doubled in 10 years (250,000 to 600,000), now 6th largest patent filer
- China: 20 IP applications per minute, world's leading filer



#### **Tech Innovation Explosion**

- Digital technologies leading the innovation race
- 4.5 million computer & digital communications patents filed since 2011, double the previous 20 years
- Al-related patents growing 5x faster than average



### ASEAN – A Regional Powerhouse

- ASEAN emerging as a major IP hub
- ASEAN Trademarks Overtake Europe in 2023
- Combined filings reach 510,000, surpassing Europe, only behind China and US
- Trademark applications doubled in ASEAN since 2010





#### **ASEAN IP Register - Background**

- August, 2023
- ➤ Launching Ceremony, WIPO-ASEAN Economic Ministers Meeting (AEM), Semarang, Indonesia
- November, 2023
- > 71st AWGIPC Meeting, Lombok, Indonesia
  - Endorsed 5 additional advanced database services
  - Endorsed ASEAN IP Register as a data-sharing platform, with individual countries adopting it based on their specific priorities and needs.
  - Individual countries are currently engaged in discussions to determine the optimal way to leverage the ASEAN IP Register within their national frameworks.

#### **ASEAN IP Register - Objectives**

- IP Register with reliable data collection and up-to-date legal statuses
  - Regular and timely data updates
  - Processes to "certify" legal events and related data at sources
- Streamline national data dissemination processes with data quality control measures
- ASEAN data standard
- IP Portfolios and statistics to build a better end-user experience
- Data coverage map with clear updates indicators



#### **Future Priorities for ASEAN IP Register**

- By creating a single, one stop portal that gives free online access to the region's patent, trademark and design records, enterprises, professionals and others can access the Register to make strategic decisions based on the latest IP data and trends.
- The register is designed to be accessible and mobilefriendly, and it will give policymakers, businesses, and individuals access to real-time IP data and trends to help them in decision-making. It will also provide the foundation for IP offices to provide additional business services to enterprises.


