

ASEAN IP Register - Background

- August, 2023
- ➤ Launching Ceremony, WIPO-ASEAN Economic Ministers Meeting (AEM), Semarang, Indonesia
- November, 2023 (71st AWGIPC, Lombok, Indonesia)
 - Endorsed 5 additional advanced database services
 - Endorsed ASEAN IP Register as a data-sharing platform, with individual countries adopting it based on their specific priorities and needs.
- April, 2024 (72nd AWGIPC, Danang, Vietnam)
 - Acknowledged ASEAN IP Register as ASEAN IP Data Gateway
 - Shared the framework of data sharing hub



ASEAN IP Register - Objectives

- Authentic Gateway to ASEAN IP Data
 - Regular and timely data updates
 - Processes to "certify" legal events and related data at sources
- Streamline national data dissemination processes with data quality control measures
- ASEAN data standard
- IP Portfolio management and Business Intelligence
- Data coverage map with clear updates indicators
