- Publishing , printing , copying techniques : In 1998 , 3111 trademarks were registered and published in the Industrial Property Gazette.

- Classification and reclassification activities; Classification systems used :
- * 3642 trademark applications have been classified,
- * Classification system used: International Classification of Goods and Services for the Purposes of the Registration of Marks (Nice Classification) and International Classification of Figurative Elements of Marks (Vienna Classification).
- Use of electronic classification systems to check the classification symbols furnished by an applicant and which are contained in the lists of goods and/or services : Not yet .

- Training courses for national and foreign participants: During 1998 the National Office of Industrial Property by itself or in co-oporation with WIPO,EPO and JPO, and local organizations /institutions organized 20 seminars and training courses on patent documentation and information.
