Since 2017, the number of industrial design applications irregularly increases and decreases. Concerning amount of registered industrial designs, there was an decrease in 2022 in comparison with 2021.

The 13th edition of the Locarno Classification has been used in 2022. Since January 1, 2023, 14th edition started to be used.

Bibliographic data and processing

Registered designs are searchable by proprietor as well as the former proprietor (for IPO CZ employees only), designer, by date of filing, registration and publication, by number of application and registration, and by indication of the product, legal status and the Locarno class and subclass, as well as by registration and application number, number of the publication Bulletin, and proceeding status.

III. SOURCES OF INDUSTRIAL DESIGN INFORMATION PROVIDED BY THE OFFICE

Main types of publications in the field of industrial design information, outline of the content (industrial design applications, design patents, registrations, etc.) and medium (on paper, on CDs, online - URLs)

Office notices are published weekly in the electronic Official Bulletin of the Industrial Property Office of the Czech Republic. Notices are also published at the Office's website.

Mass storage media used are hard discs, magnetic tapes for backup and paper.

Official Gazettes: main types of announcements, frequency of publication, medium (on paper, on CDs, online - URL), etc.

Publishing, including printing, copying techniques and electronic printing

Lists of designs which have been registered, renewed, corrected, or which have requested restoration are published weekly in the Official Bulletin of the Industrial Property Office of the Czech Republic. Since 2007 an electronic weekly (updated on Wednesdays) Bulletin has been published at the Office's web site (<https://upv.gov.cz/en>). No prior registration or subscription to view the Bulletin is needed; however the pdf viewer (e.g. Adobe Reader) must be installed. The information as published is the authentic one for legal purposes.

Main types of announcements of the Office in the field of industrial design information

Office notices are published weekly in the electronic Official Bulletin of the Industrial Property Office of the Czech Republic. Notices are also published at the Office's website.

Mass storage media and microforms used

Used mass storage media are hard discs, magnetic tapes for backup and physical original in paper version.

Databases and office automation

Registered designs, including Community designs (RCD), are searchable in the public database. It provides a range of search options including proprietor, designer, image, indication of the product, legal status, date of filing, registration and publication, and Locarno class and subclass. The Official Bulletin picks up data from the internal database.

IV. ICT SUPPORT TO SERVICES AND ACTIVITIES RELATED TO INDUSTRIAL DESIGN INFORMATION CARRIED OUT BY THE OFFICE

Specific software tools supporting business procedures within the Office: general description, characteristics, advantages, possible improvements

Within the Office, there are obeyed, maintained and improved several business management systems:

- ISO 9001 – QMS (Quality Management System) helps to assure a constant level of quality of services provided by the Office
- ISO 27001 – ISMS (Information Security Management System) specifies a management system that is intended to bring information security under explicit management control. Fields of concerns are Security policy, Asset management, human resources security, access control, incident management system etc.

The business process management system (BPMS) internally named ADONIS that describes the office's processes flow structure is also deployed, maintained and improved. Each employee can find information on organizational structure, valid laws, rules and other documents, available applications, databases and information systems.

Hardware used to supporting business processes of the Office

Workstations - HP, processor Core I3 and Core I5, RAM 4- 16 GB, HDD 160 - 500 GB. 300 workstations (aprox. 60 laptops, 240 desktops) connected in the Office network are of the Office staff direct service. Thereof 50 computers connected in the Office network are intended for the clients of the Office and staff training. MS OFFICE – 2013/2016 and Office 365 software. The Office uses CD, DVD and magnetic tapes as data mediums.

Internal databases: coverage, updates, interlinks with external sources

In-house systems (online/offline)

The Office maintains an in-house search database of national applications of industrial designs and registered industrial designs. The database is not accessible to the public, but its structure corresponds to the public database (which contains only national registered industrial designs since no. 3500 and Registered Community Designs).

External databases

The Office provides publicly free access to the database comprising the data concerning registered national industrial designs since no. 3500 and registered community designs at the IPO CZ website <https://upv.gov.cz/en/information-sources/national-databases/industrial-design-databases>

The Office also performs searches in design databases freely accessible in the Internet such as Hague Express Database (WIPO), eSearch plus, DesignView (both maintained by EUIPO) and other national databases. Establishment and maintenance of electronic search file: file building, updating, storage, documents from other offices included in the search file

File building

The industrial design search file consists of the collection of registered industrial designs of the Czech Republic and Czechoslovakia. The full retrospective collection of registered and published industrial designs is accessible via public database. The database contains bibliographic data as well as images of approx. 34000 published national registrations. The oldest data comes from the 1966/67 turn of the year.

Updating and Storage, including mass storage media

The data is updated daily and stored electronically (official databases, hard discs, magnetic tapes for backup) and in a paper version.

Documentation from other offices maintained and/or considered part of the available search file

Collections of official bulletins of foreign offices are available in an electronic form (via internet or in a paper or on CDs/DVDs (older volumes)). WIPO and Community Design Bulletin are available in electronic version via internet (new volumes) and in CD/DVD version (previous volumes).

Administrative management electronic systems (register, legal status, statistics, and administrative support)

The Office uses the internal information system SYPP2 (starting from January 2014) to proceed the applications of patents, supplementary patent certificates, utility models, industrial designs, trademarks and geographical indications. The system has been developed since 2011 as a major upgrade of previous version SYPP which was used from 2004 until 2013. The application is flexible, based on Oracle Forms with easier maintaining and flexible data structure. Data is stored in xml format including the history. The system is also user-friendly. System is connected with central registers of the Czech Republic (ISZR). The system enables to maintain official registers of all the industrial property rights. Furthermore, it archives all incoming and outgoing communications of the Office, provides the information on the state of proceeding, legal status of registrations and statistical data. The Document Management System (DMS) is integrated as well. The data are transferred to the electronic Office's Bulletin and to the public search database. The system is compatible with electronic filing recognizing authorized electronic certificates. The current version of on-line filing system was launched in 2017 and is based on a web application. This system has replaced the previous application which was based on pdf forms. Starting from January 2008, the system produces automatic electronic extracts from registers upon online request.

Information services available to the public

The information centre and the helpdesk operate during the working days. They provide the general information concerning the industrial property rights.

Design information services for the public are provided within the information centre, in the public reading room, common questions can be addressed to the helpdesk (helpdesk@upv.gov.cz) and search requests and orders to the search section 1objednavky@upv.gov.cz). The Office received a total of 3 design search requests in 2022. A total of 3185 searches (for patents, designs, trademarks) were provided for the State administrative bodies.

The Office provides full range of brochures and flyers free of charge. They can be downloaded in PDF format from the Office's web site, taken in the office headquarters or sent upon request. The Office publishes its own books and the Industrial Property Journal (4 issues per year) reflecting the current issues of IP rights.

V. PROMOTION ACTIVITIES AIMED TO SUPPORT USERS IN ACCESS AND EFFICIENT USE OF INDUSTRIAL DESIGN INFORMATION

Office's library (if deals with industrial design information): equipment, collection management, network of libraries in the country, cooperation with foreign libraries

Patent library stores the industrial design collection which consists of registered industrial designs of the Czech Republic and Czechoslovakia. The full retrospective collection of registered and published industrial designs is accessible via public database or in paper form. The database contains bibliographic data as well as images of approx. 34 000 published national registrations. The oldest data comes from the 1966/67 turn of the year. The documents can be studied in the public reading room equipped with PC workstations available for visitors.

The Office cooperates with Regional Patent Information Centres (PATLIBs) on IPR information dissemination.

Publications related to different business procedures and industrial design information sources available to users, for example, books, brochures, internet publications, etc.

The Office provides the full range of all IP rights dedicated brochures, leaflets and guides free of charge. They can be downloaded in PDF format from the Office's web site <https://upv.gov.cz/en/information-sources/publications/information-brochures>, taken in the office headquarters or sent upon request. All the materials are distributed to visitors during fairs. The Office publishes its own books.

The Industrial Property Journal reflecting the current issues of IP rights is published four times per year (both in paper and electronic versions, <https://upv.gov.cz/informacni-zdroje/publikace/casopis-dusevni-vlastnictvi>).

Cooperation with universities, technology and innovation support centers, etc.

In 2022, the Office continued its expert and teaching cooperation with universities. In addition to pedagogical documentation, IPO CZ offers the possibility of training teachers and holding lectures and discussion seminars for students. These activities took place either onsite or on-line in 2022. Lectures were given, for example, to students of the Prague University of Economics and Business, the University of Chemistry and Technology, Prague, the VSB – Technical University of Ostrava, and the Technical University of Liberec. Online lectures were held at a number of innovation, technology and PATLIB centres.

Education and training: training courses, e learning modules (URLs), seminars, exhibitions, etc.

The IPO CZ regularly organizes a wide range of training courses and seminars - such as Designs - National and International Legal Protection, Searches in the National and Foreign Design Databases, IP Protection and National (CZ) and International Systems of IP Protection, Intellectual Property Protection in Business (SMEs), Enforcement of Intellectual Rights, IP Jurisdiction (administrative and judicial issues). All the educational activities are organized for the public, mainly for students, academic staff of universities, representatives of SMEs or research institutions and IP professionals.

Every year, a two-year distance study learning of industrial property rights begins within the Industrial Property Training Institute – Office's own educational facility.

In total, In total, more than 50 lectures were presented by Office employees in 2022 (both onsite and online)

Other activities

The IPO CZ continued its activities for children and youth (elementary school pupils and secondary school students). The Office offers to them short training sessions on industrial rights, guided tours to the Office's headquarters and an example search in patent databases, as well as courses for teachers interested in adding the topic of IP to their curricula. A special section for youth was maintained on the IPO CZ website. The leaflets and comics on the topics of patents, trademarks, industrial designs and copyright can be downloaded in this section. All the materials mentioned are also available for children and youth during their excursions to the IPO CZ or during the fairs and exhibitions. The e-learning course on industrial property for elementary and secondary school students was maintained. The course acquaints young people with the principles or individual institutes of industrial property rights protection in an entertaining way. The IPO also kept on cooperating with the RVP.CZ Methodological Portal, operated by the National Institute for Education to support teachers.

The IPO CZ presented itself at the Vdafest [Science Festival] and Veletrh vdy [the Science Fair] in 2022. The Vdafest event, aimed at students and pupils of primary and secondary schools, intends to support their interest in science, technology and the study of technical fields, and is organised annually by the House of Children and Youth of the capital Prague, the Czech Technical University and the University of Chemistry and Technology, Prague. Veletrh vdy is organised by the Czech Academy of Sciences [CAS] and it is the largest popular science event in the Czech Republic showing all forms of science. Among exhibitors are individual CAS institutes, universities, innovative companies, and educational institutions presenting their activities.

On World Intellectual Property Day, 26 April 2022, the Office prepared a special website where visitors could watch a performance by *Úžasné divadlo fyziky [the Amazing Theatre of Physics]* on making use of physical phenomena in well-known inventions. Visitors could also view a Czech Academy of Sciences exhibition on Czech scientists and their inventions, and attend the following webinars: The Espacenet database, Intellectual property rights—introduction to copyright, intellectual property rights—introduction to industrial property rights. Visitors to the website could also watch videos devoted to individual types of industrial property rights, and materials and games were available for download on the topics of intellectual property rights and industrial property rights.

VI. INTERNATIONAL COOPERATION ACTIVITIES IN THE FIELD OF INDUSTRIAL DESIGN INFORMATION

International exchange of industrial design information in machine-readable form (e.g., Official Gazettes)

The Official Bulletin of the Industrial Property Office of the Czech Republic is published exclusively electronically as of the beginning of 2007. The Official Bulletin is published on a weekly basis (updated every Wednesday) instead of the monthly basis as it was before. The paper version has been discontinued. Electronic version of the Official Bulletin has been available since 2000 (Czech version, English version has been available since 2007) and accessible at the Office's web site:

Participation in international or regional activities and projects related to industrial design information

Once entered into the registry run by the European Union Intellectual Property Office (EUIPO) in Alicante, Spain, design owners gain protection for the entire territory of the European Union. The IPO CZ has been integrated into the [Designview](#) database, becoming the eleventh National Office to do so. The Office actively participates in a number of EUIPO projects aimed at harmonising the activities of national industrial property offices and the Community design system. These projects are especially focused on quality of services, provision of information to users and raising awareness of the importance of legal protection of industrial designs.

Since 2008, upon the European Union's joining into the Geneva Act of the Hague Agreement Concerning the International Registration of Industrial Designs, Czech applicants have had the possibility to use the international industrial design protection system. The system is managed by the International Bureau of the World Intellectual Property Organization (WIPO).

Assistance to developing countries

At the request of foreign IPOs (or WIPO) the Office offers study visits for their staff members.

Other activities

The IPO CZ continued to fulfil responsibilities resulting from the Czech Republic's membership in the European Union especially related to the area of industrial property protection. In the second half of 2022 we took over the presidency from France. CZ PRES managed to achieve a compromise on the entire text of the regulation on the protection of geographical indication for craft and industrial products, and the presidency's objective of approving a general approach, at the Competitiveness Council in December 2022. During the Czech presidency, the revision and modernisation of the EU regulation on industrial designs was also initiated and presented at the last December meeting of the Working Party.

Discussions at the Working Party meeting focused primarily on issues stemming from the Action Plan on Intellectual Property, especially reform of the industrial designs protection system (and the possibility of introducing protection of geographical indications for non-agricultural products) in the EU, and support for small and medium-sized enterprises in the use of intellectual property rights.

IPO CZ continued its active cooperation with EUIPO, whose main tasks are to administer and promote the system of EU trade marks and Community designs, and to promote the convergence of practices and tools in the field of trade marks and designs in cooperation with IP offices of the Member States
