## Annual Technical Report 2006 on Trademark Information Activities submitted by Lithuania (SCIT/ATR/TM/2006/LT)

### I. Evolution of registration activities

Application filings and registrations in 2006:

2543 applications filed direct with the State Patent Bureau of the Republic of Lithuania (SPB), from which 82.8 applications originating in Lithuania (including 86 international applications);  
2922 trademarks registered;  
4110 positive decisions to grant international trademark protection in Lithuania made.

Compared with 2005 the number of:

filings direct with the SPB increased by 8.1;  
filings originating in Lithuania increased by 7.0;  
Lithuanian trademark registrations increased by 63.5;  
positive decisions to grant international protection in Lithuania decreased by 9.8.

Lithuania, United States of America, Russian Federation, Switzerland and Estonia are the leading countries of origin as reflected in filings in 2006.

The distribution of SPB Official Gazette in foreign states and intergovernmental organisations on the basis of mutual exchange is effected also by LTL.

#### **VII. Matters concerning mutual exchange of trademark documentation and information**

The official gazette of SPB was distributed in 39 foreign states and intergovernmental organisations (AM, AT, BA, BG, BY, BX, CH, CZ, DE, EE, EM, EP, ES, FI, FR, GB, GR, HR, HU, IE, JP, KG, KZ, LV, MD, MK, PL, RO, RS, RU, SI, SK, TJ, TM, TR, UA, US, UZ, WO) on the basis of mutual exchange.

The bibliographic and legal status data on trademarks was supplied to THOMSON/COMPU-MARK to be included in COMPU-MARK databases.

## **VIII. Matters concerning education and training including technical assistance to developing countries (please indicate URLs of web pages of the Office's website wherever appropriate)**

Lithuanian specialists took part in WIPO Standards and Documentation Working Group (Seventh Session) of Standing Committee on Information Technologies.

The following seminars were organized together with WIPO in 2006:

national seminar Regarding the Use of Trademarks in Business and Trade;

regional seminar Coordination of the World Intellectual Property Organization Universities.

Seminars on the protection of the industrial property in Lithuania and patent information service were held in Kaunas and Siauliai in 2006.

World Intellectual Property Day has been celebrated, an exposition dedicated for the World Intellectual Property Day and for the 15th Anniversary of the SPB has been organized at LTL.

Upon active cooperation with the WIPO, a University Initiative program is being implemented in Lithuania, according to which industrial property information coordinators operate in Vilnius Gediminas Technical University as well as in Kaunas University of Technology.

In cooperation with WIPO Lithuanian language publication Inventing the Future - An Introduction to Patents for Small and Medium-sized Enterprises has been published.

Lithuanian press published articles on the improvement of the Lithuanian industrial property information system.

Bibliographical index The Protection of the Industrial Property (where books and articles of the Lithuanian authors in field of industrial property for years 1991-2006 indicated) is maintained and information publication Protection of the Industrial Property is published every quarter by LTL as well.
